On October 08, 2020, the Philippine Competition Commission resolved to take no further action with respect to the proposed purchase by GT Capital Auto Dealership Holdings, Inc. ("GTCAD"), a whollyowned subsidiary of GT Capital, and Toyota Corolla Sapporo Philippines Holdings, Inc. ("TCSPHI"), a wholly-owned subsidiary of Toyota Corolla Sapporo Corporation, Ltd. (Japan), of Toyota Motor Philippines Corporation's one hundred percent (100%) stake in Toyota Santa Rosa, Laguna, Inc. ("TSR").
