#### Item 9. Other Events

On March 10, 2016, the Board of Directors of GT Capital Holdings, Inc. ("GT Capital") approved the declaration of (a) a regular cash dividend in the amount of Five Hundred Twenty Two Million Nine Hundred Thousand Pesos (PhP522,900,000.00), or Three Pesos (PhP3.00) per share, and (b) a special cash dividend in the amount of Five Hundred Twenty Two Million Nine Hundred Thousand Pesos (PhP522,900,000.00), or Three Pesos (PhP3.00) per share, in favor of GT Capital's Common stockholders.

The Board of Directors also approved a regular cash dividend in favor of its Voting Preferred stockholders at a dividend rate of 3.77%, the 3-year PDST-R2 rate on issue date (April 13, 2015).

The record dates for the cash dividend pertaining to both the Common Shares and the Voting Preferred Shares will be on April 8, 2016 with payment dates on May 4, 2016.
